

**STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF MOUNDSVILLE,  
JANUARY 15, 2013**

The Council of the City of Moundsville met in regular session in the Council Chambers on January 15, 2013 at 7:00 p.m.

Meeting was called to order by Mayor Eugene Saunders.

Invocation by Councilperson Mark Simms.

City Clerk Hewitt called the roll and the following councilpersons were in attendance: DeWitt, D. Haynes, P. Haynes, Remke, Simms, Wood and Mayor Saunders. Also present: Fire Chief Clarke, Police Chief Mitchell, Street Commissioner Richmond, Building Inspector Richmond, Attorney Thomas White, CPA Kathryn Goddard and City Clerk Hewitt. Absent: City Manager Deanna J. Hess.

**Regular Council Meeting of January 2, 2013.**

Councilperson P. Haynes moved to accept and approve the minutes of the regular council meeting of January 2, 2013, seconded by Councilperson Simms.

**GENERAL PUBLIC HEARING:**

\* Allen Hendershot, 1 Hess Court, provided council with an overview of progress at the Sanford Center reporting that rentals of the community room and gym are going well; a recent donation was received from the Marshall County Commission; a steak fry is scheduled for February 16 in the gym tickets are \$15 per person. The Center is trying to establish a Boys & Girls Club with after school programs.

Councilperson Wood asked Mr. Hendershot if he could meet with the City Manager to renegotiate the lease agreement which has expired. The Policy Committee discussed signing the lease every 5 years instead of yearly.

**Discussion and Approval of an Ordinance to Abolish the Moundsville Building**

**Commission. (First Reading)**

Attorney White read the following ordinance by title only to be passed by council on first reading:

**AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, ABOLISHING THE MUNICIPAL BUILDING COMMISSION. (FIRST READING)**

Councilperson Wood moved to accept and approve the ordinance to abolish the Moundsville Building Commission, seconded by Councilperson Remke.

Mayor Saunders called for a voice vote. City Clerk announced the following tally. D Haynes, P Haynes, Remke, Simms, Wood and Mayor Saunders. 7 yeas. Motion carried unanimously.

\* Councilperson Wood discussed the possibility of Moundsville applying for “Home Rule”.

\* Councilperson Wood announced that Professor Margaret Stout and WV Students will meet on January 25, 2013 from 11-2 p.m. at the MEDC Mollahan Building to continue drafting the Moundsville Comprehensive Plan.

\* Councilperson Wood believes monies are still available for projects from the Community Participation Grant Funds. Council needs to provide a list of projects to submit to the delegates at the Municipal League Conference in February.

\* Councilperson Wood said he and Manager Hess are moving forward with inviting Moundsville’s youth to council meetings.

\* **Haynes, P** - Nothing at this time.

\* **DeWitt** - Commended the Street Department for keeping up on street maintenance.

\* Said she received a compliment from a citizen who was pleased with council's accomplishments.
